Reconfirm how instruction (Return to Learn Plan) is going to be delivered during the 20/21 school year:

A special meeting of the Board of Education was held on November 4, 2020, to review the previously approved plan to return students to hybrid learning on November 9, 2020. Oakland County has moved from a C to an E on the school building spread indicators. Guidelines from Oakland County Health Division state that "Building(s) with known cases in staff or students but no ongoing transmission "should" consider remote instruction in the entire district." We are currently experiencing a high number of staff members needing to quarantine due to health situations in their homes. There is a low availability of substitute teachers at this time. Oakland County Health Division expects cases to rise in the coming weeks due to possible increased mobility during the holiday times and has recommended that districts who are currently in a remote learning environment remain remote. With these considerations in mind, all Royal Oak Schools PreK-Post secondary programming will remain remote until January 29, 2021.
